SUMMARY OF SCOPE FOR WORK:

Detailed Project management and Construction Supervision Services

To provide project management and construction supervision services throughout his contract period. He shall ensure that all the activities/services are provided in a professional manner to facilitate project progress and delivery

• Construction Contract Mobilization

Review and identify the requirements of the mobilization period of the construction Contract(s)

Review and Approval of Designs and Submittals

Review and approve the designs and calculations prepared by the contractor such as finalizing the route of pipelines, hydraulic analysis, structural analysis, detailed drawings of all works elements including reinforcement details, bar bending schedules and standard details, ... etc.

Review the Work Program submitted by the Contractor,

The Consultant shall conduct risk identifications, assessment and analysis exercise with the involvement of the contractor(s), as required, and keep the risks register developed at all phases of work and updated throughout the supervision stage

Health, Safety and Environment

During supervision stage, the consulting Engineer shall submit the HSE Management Plan during the mobilization period. The Consultant shall ensure that all works carried out during the course of this project, comply with the full provisions of the relative Health, Safety and Environment requirements

Quality Management

The Consultant shall demonstrate that he is maintaining a corporate Quality Management System (QMS). The Consultant shall establish appropriate Internal Audit procedures to verify compliance with his own Quality Management System requirements during the course of work.

• Material Standardization and submittals

Review the proposed material for the project. The Consultant shall make self-aware of the existing and approved materials

Completion of Works

At the stage when the works have reached substantial completion, the Consultant must inspect the works and ensure that all works have been completed in full compliance to the contract requirement.

• Defects Liability Period

During the defects liability period, the Consultant shall liaise with the Client regarding completion of snags, defected material/equipment (if any) and resolution of any contractual issues thereof that may arise during the defects liability period

Claims and Contractual Disputes

The Consultant, who is defined as the Engineer to the Contract, must assess and reply, in a timely manner as per the requirements of the construction Contracts, to all claims by the Contractor(s) and assist the Client with resolution of disputes within the provisions of the Conditions of Contract.

Time for Completion of the Works

The whole Contract period for completion the works is Twenty Six (26) Months
