

Call off Maintenance of Own Vehicles and Equipment for Three Years

SCOPE OF WORK:

The scope of work is to complete maintenance of Own Vehicles and Equipment as and when required by Oman Water and Wastewater Service Company SAOC either between working hours or after working hours on call-off.

The Contract scope covers the following services for the units:

- a. Preventive Maintenance.
- b. Corrective Maintenance.

Preventive Maintenance.

- 1- The contractor should give Oman Water and Wastewater Service Company SAOC vehicles / truck and equipment priority either in preventive maintenance to avoid any delay in Oman Water and Wastewater Service Company SAOC business.
- 2- All spare parts which are required to be change during preventive maintenance like air filter, oil filter, fan belt etc., must be genuine
- 3- The contractors must test the truck and equipment before handing over to Oman Water and Wastewater Service Company SAOC and ensure the truck and equipment free of defect.
- 4- The contractor must allow Oman Water and Wastewater Service Company SAOC Fleet maintenance team to supervise the maintenance work in his workshop and action the necessary recommendation from the Fleet team.
- 5- The contractor must attend the preventive maintenance in the site for unmovable equipment like Forklift 2 Tons (Electrically Operated), Forklift 3 & 4.5 Tons (Diesel Operated).
- 6- The contractor will ensure that periodic service & necessary repair is carried out at contractor's service yard with proper service schedule management in liaison with client according to establish program either by Hours, Kilometres or days used.
- 7- The client reports immediately if any abnormality or malfunction observed in the vehicle to the nearest contractor's service centre.
- 8- It is the contractor responsibility to take the signature of the person to whom the vehicle handover as the basis of satisfactory completion of the service or repair and the signed copy must enclosed at the time of claim.
- 9- If any vehicle required attention at client's premises than contractor must attend the job at specified location without any deputation charges to inspect the vehicle.
- 10- The Service scope includes adjustment of valve clearance, air filter replacement, hub servicing, break overhaul, radiator flushing, replenishment of coolant, brake system cleaning / adjustment etc.

- 11- Contractor must provide the standard of workmanship using genuine parts, recommended lubricants, and special stools.
- 12- Contractor must submit a general report on the defect noticed during service to the client for client's perusal and necessary approval for carrying out the jobs.
- 13- The contractor shall execute the works in strict according with the general requirements of the contract and to the satisfaction of the client and shall comply with and adhere to all instructions and directions on services whether specified or not.

corrective maintenance:

All Corrective maintenance works for example dent repair, painting etc. shall be executed with the prior approval of OWWSC.
