BRIEF SCOPE OF WORK/SERVICES

The Consultant is required to oversee the activities of all the Technical, Legal, Financial, Contractual and Environment consultants, and shall obtain their input to the decision-making process as required. It is required for the consultant to select the Technical, Legal, Financial, Contractual and Environment expertise to successfully develop a Public-Private-Partnership (PPP) Tender document.

The scope of the consultant services is to following items:

- a) Data collection closely working with NWS team to cover all their requirements.
- b) New STP (Sewage Treatment Plants) for A' Seeb III, IV and Ansab III:

Preparing tender for project development (award, execution and O&M) of new Sewage Treatment Plants (A' Seeb III, IV and Ansab STPs III). Bidder shall elaborate in detail the methodology for each of the 4 Phases:

- Phase I: Project Identification from LOA (including kick of meeting, financial model, and Pre- Investment Appraisal Document (PIAD), (BOO or BOOT, EPC) preparation, selecting type of PPP contract and all other documents required for phase II.
- Phase II: Invitation to Initial Negotiation (including tender documents preparation).
- Phase III: Tender Evaluation & Negotiation.
- Phase IV: Award (including finalizing the contract documents, commercial and financial closure).
- c) PPP contract for Operation and Maintenance Scope Related to the Exiting A'Seeb & Ansab STPs:
- Evaluate the performance of the existing Assets at the STPs and create factors for pricing for bidders to operate and maintenance of each plant.
- Prepare Tender Documents for Operation & Maintenances of these plants, to be operated under PPP contract type for period (5-10) years.
- Tender Evaluation & Negotiation.
- Evaluate the performance of the existing Assets at the STPs and recommend ways of improvements to reduce O&M costs and create factors for pricing for bidders to operate and maintenance of each plant.
- Prepare Tender Documents for Operation & Maintenances of these plants, to be operated under PPP contract type for period (5-10) years or as per recommendation of feasibility study.
- The consultancy contract shall include Tender Evaluation & Negotiation.
